Fagerhult acquires Eclairage Conseil Lyonnais (ECL) in France.

In order to further strengthen its position in the European Lighting Industry and to create a platform for growth in the important French market, Fagerhult today announces the acquisition of the French Retail lighting company ECL as of 29 November 2006. The acquisition will have a positive effect on the full year profit per share in 2007.

"It is in our strategy to be among the top three Lighting Systems providers in Europe through profitable growth. With this acquisition we further strengthen our position in the important French market", says Per Borgvall, CEO Fagerhult.

"ECL is a specialist company with its core business in the Retail Lighting segment, which is a perfect fit to Fagerhults strategic objective to grow in this market segment".

The company is based in Saint Genis Laval, just outside Lyon in France and has 25 employees. The business has a healthy profit, growth momentum and a well established position in the Retail segment in the French market. After the acquisition of ECL the combined Fagerhult sales turnover in France will be approx €8m (72 MSEK).

Brand profiling and increased insight in which way light influences our purchasing patterns and behaviour have generated substantial growth in the Retail Lighting market.
